## **NOTES:**

(1) The Town Board has determined that the costs related to hiring of engineers, planners, attorneys, and other qualified experts to review certain license and permit applications on behalf of the Town should be the responsibility of an applicant. Therefore, a cash deposit into a non-interest bearing account at the time a license or permit application is received MAY be required to be submitted to the Town in an amount to be determined by the Town. Said "escrow account" deposits are to be based on an estimate of total costs expected for the review and processing of licenses and permits applications as determined by the Town.
